2020 COUNSELOR-IN-TRAINING PROGRAM

The Counselor-In-Training (C.I.T.) program is an educational and job skill summer program for teen girls ages 15 to 18 years old. C.I.T.'s work as part of a team with the staff to help run activities for children ages 5-14 during our summer enrichment camp program. Our C.I.T. curriculum is designed to develop the skills necessary to be an effective leader.

Advantages of being a Counselor-In-Training, the C.I.T.'s will:

- Gain valuable work experience
- Develop new skills
- Practice leadership
- Explore future career possibilities
- Work as a team with professional staff
- Have fun helping kids from our community and being a great role model
- Receive a Program Completion Certificate documenting volunteer hours

Requirement: The C.I.T. Program is for girls ages 15 to 18 years old (age as of the program start date)

Dates: The C.I.T. Program runs daily, Monday through Friday. The program begins the week of 7/6/2020 and runs till 8/28/2020. The average hours per day are approximately 10 am to 5 pm (hours can be flexible based on teen's needs) with one wrap-up meeting scheduled in early September (tentative date 9/4/2020).

Cost: The C.I.T. Program is **FREE!** * The program also includes a lunch (most weeks) and an afternoon snack. In addition, a stipend will be awarded to the teens at the end of the program. (*each Girls Inc. member pays an annual membership registration fee of \$15.00)

How to Register: **Registration begins 6/1/2020**, this is done by completing the attached pre-application, once this is received, the teen and parent will need to fill out a Girls Inc. Membership Application Packet (this is available on our program page on our website www.girlsinclowell.org or at our Center).
